## Terms and Conditions - Program 3D Printed Part Sample Test Program

Participants in the HP Multi Jet Fusion 3D Printed Part Sample Test Program ("Program") will be eligible to receive a 3D printed part sample printed with an HP Multi Jet Fusion according to the terms and conditions set out below to test the quality of 3D Printer Parts.

By participating in the Program, you accept these terms and conditions and the decisions of HP being final and binding in all respects.

## Terms and Conditions.

- 1. You (herein after "participant" or "you") must be 18 or older. Program is valid for business customers only. Participant must provide a shipping address in either Norway, Finland, Sweden or Denmark. This Program is not open to employees of HP, their agents, wholesalers, resellers, retail staff, retailers, participating logistic service providers or anyone connected with the Program.
- 2. Offer is limited to one (1) HP-designed 3D printed part sample per company or participant, while supplies last. Not valid in connection with any other offer.
- 3. HP reserves the right to disqualify incomplete, altered or illegible Program requests.
- 4. Restrictions/conditions may apply. Any attempt by any person or company to request more than one (1) 3D printed part sample using multiple company names, email addresses, mailing addresses, or any other fraudulent mechanism, as determined by HP in its sole discretion, shall give HP the right to deny the request.
- 5. The decisions of HP in respect of any and all aspects of the Program test will be final and binding.
- 6. HP and its agencies are not responsible for lost, unintelligible, late, misdirected, incomplete, or non-delivered Program requests or emails; or for interrupted or unavailable accessibility of an Program Website, or miscommunications, or failed computer, satellite, telephone or cable transmissions, or lines, or technical failure or jumbled garbled, corrupted, scrambled, delayed or misdirected transmissions, or computer hardware or software or Website malfunctions, failures, or technical errors or difficulties, or other errors of any kind whether human, mechanical, electronics or network or the incorrect or inaccurate capture of a participant's request or the failure to capture, or loss of, any such information, caused by any equipment or programming associated with or utilized in this Program; and assume no responsibility for any error, omission, interruption, deletion, defect or delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or tampering with or hacking of any Website or equipment used for this Program. - 8. Participant assumes all risk relating to or arising from the 3D printed part sample provided under this 3D Printing Sample Test Program. To the fullest extent permitted by law, HP, its parent and affiliates and its agents shall have no responsibility for any loss or damage caused by the 3D printed part sample.
- 9. Participant will be responsible for complying with all laws and regulations including without limitation laws and regulations applicable to import and export, such as the trade control laws of the United States and any other applicable laws regarding the usage and/or supply of the 3D printed part sample. Participant who exports, re-exports, or imports or otherwise transfers products, technology, or technical data assumes responsibility for complying with applicable laws and regulations and for obtaining required export and import authorizations. HP may suspend performance under these terms and conditions i) if the Participant is in violation of any applicable laws or regulations and/or ii) to the extent necessary to assure compliance under the U.S. or other applicable export or similar regulations.
- 10. Upon registration, participants will be requested to provide certain personal data to HP and its agents for the purposes of this Program. By providing such personal data you agree that HP may transfer any such data to HP's affiliates and agents outside the UK (or the EU), for the purpose of carrying out this 3D Part Samples Test Program and for marketing and quality control analysis. Any Personal Data you provide to us in connection with this Program will be dealt with by HP in accordance with the terms specified in the HP Privacy Statement (http://www8.hp.com/us/en/privacy/privacy/html).
- 11. Participant agrees that HP shall have all title and interest in any feedback for use in manufacture, sale, marketing and/or use of 3D HP Multi Jet Fusion 3D Printers or otherwise.
- 12. HP reserves the right to cancel or withdraw the Program at any time and for any reason without prior notice.
- 13. HP reserves the right to amend or cancel the terms of this Program at any time without notice.
- 14. This Program is subject to the laws of Norway, Finland, Sweden or Denmark depending on the location of the customer requesting the part sample. The courts of that respective country will have exclusive jurisdiction on any dispute related to the Program.
- 15. The 3D Printed Part Sample will be provided to Participants free of charge subject to these terms and conditions. The value of the 3D Printed Part provided to participants of this Program is approximately £15.
